# New Medicare Legislation: More Affordable Part D Drugs for Your Patients

The Inflation Reduction Act makes improvements to Medicare that will expand benefits and lower drug costs for many of your patients.<sup>1</sup>




### Significant Reduction in Total Annual Cap

The new legislation ends the coverage gap ("donut hole") on December 31, 2024.2

Beginning in 2025, all Medicare Part D plans will **reduce the total annual cap from \$3,300 to \$2,000** on out-of-pocket costs for ALL prescription drugs covered by the plan.<sup>3,4</sup>

This change affects all standalone Part D and Medicare Advantage plans with prescription drug coverage.<sup>5</sup>



### New Monthly Payment Plan

The Medicare Prescription Payment Plan (MPPP), effective January 1, 2025, offers Part D enrollees the **option to pay out-of-pocket prescription drug costs in monthly payments** instead of all at once at the pharmacy. This optional plan may be beneficial to patients who experience high drug costs early in the year.<sup>6,7</sup>

#### Key features of the Medicare Prescription Payment Plan<sup>6,7</sup>:

- Distributes costs in monthly installments throughout the year
- Drug plan bills patients directly, replacing pharmacy payments
- No additional cost for participation
- Part D drug plans, including Medicare Advantage plans with prescription drug coverage, **must provide all Part D enrollees with the option to participate**
- Enrollees continue to pay plan premiums (if applicable)

Patients can enroll at any time by contacting their plan or visiting their plan's website.

Payments under MPPP may vary each month, but your Part D patients will never pay more than the \$2,000 annual out-of-pocket cap in 2025.8

### Enhanced Low-Income Subsidy for Medicare Part D

The Extra Help program, also known as the Low-Income Subsidy (LIS), has expanded to provide greater prescription drug cost assistance to eligible Medicare beneficiaries.<sup>9</sup>

Your patients may be eligible in 2025 if they meet these qualifications<sup>10</sup>:

	Annual income limits*	Resource limits <sup>†</sup>
Individual	\$22,590	\$17,220
Married couple	\$30,660	\$34,360

Some patients are automatically enrolled in the Extra Help program, including patients who are dual-eligible for Medicare and Medicaid, those with Supplemental Security Income (SSI), and those enrolled in other Medicare Savings Programs (MSPs).<sup>10</sup>
